

As well, we felt it was important to establish wildlife corridors and shelterbelts in a strategic plan that would enhance productivity and take advantage of our property's location between the Strathbogie Ranges and the Longwood Plains. As a member of the Nagambie Landcare Group, I participated in courses, including Whole Farm Planning and Box-Ironbark Ecology and contributed to on-going tree planting and weed removal projects. More recently, we have participated in the squirrel glider nesting box program.

Between 2006 and 2013, we committed to 6 re-vegetation projects, taking up 12% of our property. These projects fell within the Longwood Biodiversity Action Project /Goulburn Broken Regional Catchment Strategy. As our projects matured, we hosted a number of community field days and information sessions on our property. In 2011, I joined the Committee of the Longwood Plains Conservation Management Network.



As increasing numbers of people become urbanised, strong urban Landcare groups and networks will be critical in helping to: preserve and improve our public open spaces; educate councils, developers, and homeowners about how to protect important ecosystems; re-connect landscape corridors; and connect people with nature for their own health and that of the environment.
